- Top 3 home choices (Plan, Level, Price Range)

STEP 2:

Within 24 hours, you will receive an email back from Townline with an appointment time that <u>you must</u> <u>confirm to secure your appointment</u>. OR you will be informed that you've been placed on our waiting list.
